

### Summary of duties:

Leads a team of boiler plant operators. On a regular and recurring basis, utilizes boiler knowledge and skill to lead a team of boiler operators in the performance of various related work. Responsible for maintaining compliance with all applicable regulations, base orders, and administrative forms relating to boiler operations. Responsible for developing written operating and maintenance procedures to ensure the safe and efficient operations and maintenance of boilers and related equipment. Operates and maintains (3) 21 MBTU Fire Tube Boiler Systems that produce steam or high temperature hot water for the laundry and dry-cleaning plant. Starts, operates, adjusts, and stops single or multiple boilers. Operates and controls auxiliary pollution control equipment requiring continuous attention to monitor efficiency and control formation of pollutants in accordance with local and the installation pollution control requirements. Maintains, repairs, schedules inspections, and installs replacement parts on boilers and auxiliary equipment for boilers. Performs other incidental duties as assigned.

#### **Basic Qualifications:**

Qualification requirements emphasis is on the quality of experience, not necessarily the length of time. Although a specific length of time and experience is not required, you must show through experience and training that you possess the quality level of knowledge and skill necessary to perform the duties of the position at the level for which you are applying. Although a specific length of training and/or experience is not required, applicants must have sufficient training and experience, paid or unpaid, of sufficient scope and quality that fully provides the ability to perform the full range of duties of the position.

### KNOWLEDGE, SKILLS AND ABILITIES (KSAs): Your qualifications will be evaluated on the basis of your level of knowledge, skills, abilities and/or competencies in the following areas:

- Quality of experience in the same line of work (experience in laundry related duties).
- Must possess a valid GOJ Class-1 Boiler Expert License is required (1級ボイラー技士免許). 2.
- Must possess a valid GOJ Boiler Maintenance Technician License (ボイラー整備士免許). 3.
- 4. Must possess a valid GOJ vehicle driver license (自動車運転免許).
- Ability to speak, read and write English at elementary proficiency (LPL: 1) is required; however, excellent command of English is strongly desirable.
- 6. Knowledge and experience in using computer such as Outlook, Excel and Word etc. are preferable.

#### Job Related Requirements:

- 1. Requires good manual dexterity.
- 2. Must be able to stand for long periods of time.
- 3. Sound verbal, written and interpersonal communication skills.
- 4. Sound planning, leading and organizational abilities- able to motivate.
- 5. Good fault finding and diagnostic skills.
- 6. Familiar with Technical Research and Maintenance requirements of related equipment and structures.
- 7. Demonstrate the ability to assess work team, training requirements, and implement program for development.
- 8. Requires excellent eyesight and be able to distinguish colors (cannot be color blind).
- Must be able to work on weekends, holidays and daily overtime when required/directed

**Special Factor:** This position is designated as Mission Essential which requires incumbent to report to duty or continue performing duties during emergencies or exigent situations such as but not limited to natural disasters, adverse weather, terrorist activity, radioactive/poisonous gas release, outbreak of pandemic disease or other events that may present a danger to any USFJ facility, personnel or LN employees, or which require extraordinary USFJ assistance for relief measures.
