

Summary of duties:

Manages the weekly and monthly use of subordinate workers, equipment, facilities, and materials, in an organizational segment or group. Establishes deadlines, priorities, and work sequences, and plans work assignments based on general work schedules, methods, and policies set by higher level supervisors, approves master leave schedule assuring adequate coverage for peak workloads and traditional holiday vacation time. Selects or recommends selection of candidates for vacancies, promotions, details, and reassignments in consideration of skills and qualifications, mission requirements, and recommends awards when appropriate. Oversees complete kitchen operations relating to cooking and prepping meal period requirements and advises manager if a menu item cannot be produced and requests a substitute menu item. Promotes progressive cooking, prevents finished waste enabling operation to follow Hennessy guidelines. Cleans equipment, storage areas, walls and ceilings, floors, worktables, walkin refrigerators, and duckboards. Sweeps, mops, and waxes floors. Disposes garbage and trash. Apply clean as you go procedures throughout the shift, taking care to sanitize as well as clean food handling and food contact surfaces. Advise Military staff when daily menu requires point of sales maintenance to allow cashiers availability of all items available to dining facility patrons. Coordinate with supervisors to conduct informal safety briefings to shift workers. Topics should include on and off duty behavior, safe driving and water safety. Conduct annual performance feedback sessions with Foreman A supervisors. Performs other related or incidental duties as assigned.

Basic Qualifications:

Qualification requirements emphasis is on the quality of experience, not necessarily the length of time. Although a specific length of time and experience is not required, you must show through experience and training that you possess the quality level of knowledge and skill necessary to perform the duties of the position at the level for which you are applying. Although a specific length of training and/or experience is not required, applicants must have sufficient training and experience, paid or unpaid, of sufficient scope and quality that fully provides the ability to perform the full range of duties of the position.

KNOWLEDGE, SKILLS AND ABILITIES: Your qualifications will be evaluated on the basis of your level of knowledge, skills, abilities and/or competencies in the following areas:

- Quality of experience in the same line of work (experience in the related field).
- At least three years of experience as cook or certificate of licensed cook, is highly desirable.
- 3. Ability to speak, read, write English at minimal proficiency level: LPL Pre-1 is required; however, English ability will be determined at the time of the interview.
- 4. Must be high school graduate OR equivalent.
- 5. Must possess or be able to pass Food Handler's Certification.

Job Related Requirements:

- 1. Must be able to pass Food Handler's Physical Examination (stool analysis) if necessary.
- 2. Must be able to work with other employees in a harmonious and cooperative manner.
- Must be in good physical condition.
- 4. Must be able to lift over 50 lbs (約 23kg).
- 5. May have to work outside of normal duty hours if requested.

Special Factor: This position is designated as Mission Essential which requires incumbent to report to duty or continue performing duties during emergencies or exigent situations such as but not limited to natural disasters, adverse weather, terrorist activity, radioactive/poisonous gas release, outbreak of pandemic disease or other events that may present a danger to any USFJ facility, personnel or LN employees, or which require extraordinary USFJ assistance for relief measures.
