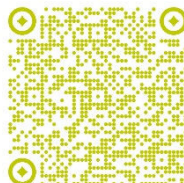

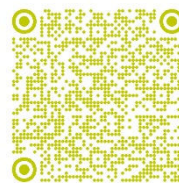

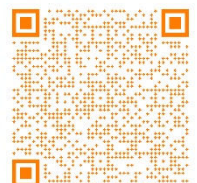

Works weekly with GeoBase office to conduct geobase reconciliations regarding linear structures, land buildings and structures and has a full administrative responsibility to reconcile with GeoBase. Collaborates with internal and external customers regarding Real Estate Transactions and fields questions related to real property. Researches and obtains missing Key Supporting Documentation (KSD) required for facilities and land transactions. Surveys, documents, and updates non-spatial data in the applicable space reporting tool as required or during routine inventories in coordination with Community Planners, Geographic Information Systems (GIS) representatives, and engineering assistants to maintain updated real property data and floor plans in the database. Coordinates changes of space allocation through the Facility Board Working Group and Facility Board, as necessary, to ensure appropriate level of approval. Assists in providing economic, social, and political impact studies of real estate acquisition, management, or disposal actions. Completes updates in NexGen Information Technology (NexGenIT). Assists in coordination for approval of CATCODE changes outside of Base Civil Engineer authority such as: housing, munitions, religious, and MWR facility changes. Ensures an accurate and complete real property inventory in the Accountable System of Record. Assists Real Property Specialists in disposal actions such as: temporary interests, facility disposal, land interests, and unique disposals such as Real Property Installed Equipment (RPIE) disposals and disposals in foreign country. Meets with stakeholders to discuss and provides input to the Construction Growth Off-Set Program. Uploads Key Supporting Documentation into NexGenITE and facility folders. Assists team members on internal and external building checks for 1-year, 3-year and 5-year inspections; completes and updates Drawing of Records. Responsible for validation of all data inputted to NexGenIT to ensure that the Accountable Property System of Record is accurate. Responsible for declaring excess property and dispose property when no longer required to support current or projected missions.
