

Summary of duties:

Performs as a working leader and exercises technical supervision over lower graded Munitions Worker employees. Sets work pace, carries out more difficult tasks, maintains group discipline, enforces safety regulations and ensures subordinates comply with established procedures and safety regulations to perform their duties. Supervises and performs a broad range or standard receiving assignments. Demonstrates proper work methods and ensures that needed material and tools are available, and that needed supplies are obtained for use. Develops deadlines, projects, and prioritizes work to be accomplished. Resolves conflicts and problems that arise, coordinates work with others, and interprets work guidelines and regulations. Maintains current knowledge of operations and answers questions of other workers on procedures, policies, methods and deadlines. Reports supervisor on status and progress of work and causes of work delays. Answers questions of supervisor on overall work operations and problems. Assists in adjusting work schedules to meet and support the mission of the organization. Tracks and manages subordinates' payroll and leave schedules to ensure section and squadron mission are not affected. Attends section & MLC supervision meetings discussing topics of operations, safety, Squadron & Wing events, regulations, exercises, training, etc. Performs and assists with munitions and industrial operation on munitions, related items and containers to include un-packing and re-packing of assets, banding, heat sealing, counting assets, palletizing asset, construction and fix containers, fillers, spacers and dunnage, barrier bag, pallet builds, chain/net operations, etc. Performs work mainly involved in assembling, disassembling, overhauling, reconditioning and reassembling all types of munitions and associated tools/equipment. Performs corrosion control on munitions and associated tools/equipment. Performs work involved in receiving, storing, issuing, caring for, cleaning, and arranging in storage all types of munitions and related components. Performs painting and remarking of munitions related items and containers. Inspects and drives Government-Owned-Vehicles (GOV) which capacity does not exceed 3 ton. Inspects and operates forklifts as required. Performs maintenance on assets during Inventory and inspection. Performs housekeeping operation in work center, operation location and storage facilities. Performs other related or incidental duties as assigned.

Basic Qualifications:

Qualification requirements emphasis is on the quality of experience, not necessarily the length of time. Although a specific length of time and experience is not required, you must show through experience and training that you possess the quality level of knowledge and skill necessary to perform the duties of the position at the level for which you are applying. Although a specific length of training and/or experience is not required, applicants must have sufficient training and experience, paid or unpaid, of sufficient scope and quality that fully provides the ability to perform the full range of duties of the position.

KNOWLEDGE, SKILLS AND ABILITIES: Your qualifications will be evaluated on the basis of your level of knowledge, skills, abilities and/or competencies in the following areas:

- 1. Quality of experience in the same line of work (experience in the related field).
- 2. Must possess <u>a valid GOJ semi medium-sized motor vehicle driver's license Manual Transmission (準中型自動車運転免許 マニュアル車)</u> and be able to drive general purpose GOVs. Must be able to drive manual transmission vehicle.
- 3. Must be able to obtain a GOJ certification for operation of forklifts with a lifting capacity of one metric ton or more (フォークリフト運転者技能講習修了証/最大荷重 1トン以上) and be able to obtain a GOV forklift license after assigned to this position.
- 4. Ability to speak, read and write English at minimal proficiency level; PRE-1 is required.
- Knowledge of explosive safety, munitions, related items, maintenance, munitions transportation and storage procedures as well as knowledge of laws, rules and regulations involved in maintenance and munitions are desirable.

Job Related Requirements:

- 1. Must be in good physical condition.
- 2. Must be able to lift and carry items weighing about 50 pounds (約 23kg).
- 3. Ability to perform job in good/close coordination with co-workers (USAF and MLC) and supervisors.
- 4. Must be physically and mentally capable of maintaining high standard of duty performance.
- 5. Must meet personnel reliability and trustworthiness standards for being involved in munitions operations.
- 6. May have to work outside of normal duty hours if directed.

Special Factor: This position is designated as Mission Essential which requires incumbent to report to duty or continue performing duties during emergencies or exigent situations such as but not limited to natural disasters, adverse weather, terrorist activity, radioactive/poisonous gas release, outbreak of pandemic disease or other events that may present a danger to any USFJ facility, personnel or LN employees, or which require extraordinary USFJ assistance for relief measures.
