EQUIPMENT RENTAL AGREEMENT, LIABILITY RELEASE AND EXPRESS ASSUMPTION OF RISK

HOLD HARMLESS AND IDEMINITY AGREEMENT: RENTOR or guardian (if under 18 years old) must initial each block and sign at bottom.

_____ Customer agrees to hold the government harmless and to indemnify for any patron misuse that results in a claim against the government.

_____ This agreement is release of the RENTORS rights to claim for injuries or death resulting from the rental and/or use of this equipment. RENTOR expressly assumes all risk of skin and/or scuba diving related in any way to the rental and/or use of this equipment. RENTOR here by acknowledges receipt of the equipment designated in this form, and, if any of this equipment is used for scuba diving, that RENTOR is a certified scuba diver or student scuba diver in a scuba diving course/program under the supervision of a certified scuba instructor. RENTOR acknowledges that this equipment is in good working condition and that he and/or she has examined the equipment to ensure that it is free from defects, including checking both quality and quantity of air in scuba tank(s) rented.

_____ RENTOR also understands that Kadena Marina and its employees, owners, officers, or agents (hereinafter "released parties"), shall not be held liable or responsible in any way for injury, death, or other damages to the RENTOR or his/her family, heirs, or assigns which may occur as a result of rental and/or use of the equipment, or as a result of product defect, or negligence of any party, including Released Parties, whether passive or active.

_____ RENTOR understands equipment **must be returned no later than 17:30**. Equipment returned after this time will be charged an additional day's rental fee.

_____ RENTOR agrees to pay for any and all rental gear upon receiving equipment and to return gear on the date specified. Equipment returned later than expected will be charged for each additional day.

_____ RENTOR agrees to return equipment in a clean condition and to pay a cleaning fee of \$20.00 if not returned clean.

_____ RENTOR agrees to reimburse Kadena Marina for the loss or breakage of any and all equipment at the current replacement value and to also pay for damages incurred while transporting, cleaning, or the use of any and all equipment.

_____ RENTOR agrees that he and/or she is responsible for any and all equipment rented and that no refunds will be issued once equipment has left Kadena Marina. EXCEPTIONS: If a class is canceled or sea conditions are too rough to dive safely, and gear is returned unused and within two hours of payment, renter may receive a rental credit.

_____ **RENTOR agrees to pay a \$50.00 fee for dunking regulator without the dust cap securely in place.**
