# Equipment Rental Agreement

## Liability Release and Express Assumption of Risk

Hold harmless and indemnity agreement: Renter or guardian (if under 18 yrs old) must initial each block and sign bottom.

\_\_\_\_\_ Customer (Renter) agrees to hold the government harmless and to indemnify for any patron misuse that results in a claim against the government (Renter).

\_\_\_\_\_ This agreement release of the renters rights to claim for injuries or death resulting from the rental and/or use of this equipment. Renter here by acknowledges receipt of the equipment designated in this form. If any of this equipment is used for scuba diving, that the renter is certified scuba diver or a student in a scuba diving course/program, under the supervision of a certified scuba instructor. Renter acknowledges that this equipment is in good working condition and that the Renter has examined the equipment to ensure that it is free from defects, including checking both quality and quantity of air in scuba tank(s) rented.

\_\_\_\_\_ Renter understands that Kadena Marina (Renter) and employees, owners, officers, or agents (hereinafter "released parties"), shall not be held liable or responsible in any way for injury, death, or other damages to the renter or family, heirs, or assigns which may occur as a result of rental and/or use of the equipment, or as a result of product defect, or negligence of any party, including Released Parties, whether passive or active.

\_\_\_\_\_ Renter understands equipment **must be returned no later than 17:30**. Equipment returned after this time will be charged an additional day's rental fee.

\_\_\_\_\_ Renter agrees to pay for any and all rental gear upon receiving equipment and to return gear on the date specified. Equipment returned later than expected will be charged for each additional day.

\_\_\_\_\_ **LATE RETURNS:** Club membership cannot be used to pay late fees on tanks. Customer cannot extend rentals via phone or email.

\_\_\_\_\_ Renter agrees to reimburse Kadena Marina for the loss or breakage of any and all equipment at the current replacement value and to also pay for damages incurred while transporting, cleaning, or the use of any and all equipment.

\_\_\_\_\_ Renter agrees to pay a **\$50.00 fine for dunking regulator without the dust cap** securely in place.

\_\_\_\_\_ Renter agrees to pay a **\$25.00 fine for a visual inspection** on any tank returned with less than 200 PSI.

\_\_\_\_\_ Renter agrees that they have check the condition of rented equipment to include mouth pieces, hoses, straps, buckles, weight pouches, zippers, mask, snorkel, left & right: booties, and fins. To ensure no broken/missing items and all sets are complete. Annotate any discrepancies on rental form, or request an issue of different piece or gear.

\_\_\_\_\_ **Renter understands that only ONE set of life sustaining equipment, to include ONE Regulator, ONE Buoyancy Compensator Device (BCD) and FOUR tanks can be rented at once per certified diver physically present at the time of rental.**

\_\_\_\_\_ Should Renter arrive at dive location and determine they no longer wish to dive due to sea conditions. Equipment can be returned for a full rental credit no questions asked provided the following:

1. Equipment is returned within 5 hours from time of rental
2. Gear is unused. Gear will be examined and if BCD and/or regulator are wet and tank under 2500 PSI then no credit will be given.
3. Rental credit will expire 30 days from date of rental.
